Congratulations Lori Brigham



The 25th Matthew F. McNulty Crystal Award was presented to Lori E. Brigham on March 14, 2024.

Lori dedicated the majority of her healthcare career to the organ donation and transplantation field. She was the founding President and Chief Executive Officer of Washington Regional Transplant Community (WRTC), the organ procurement organization (OPO) in the metropolitan Washington, D.C. area. She served as the only CEO of WRTC for 35 years before the OPO merged with its sister organization The Living Legacy Foundation of Maryland to become Infinite Legacy in January 2023.

Lori built WRTC from the ground up. In 2022, the OPO had a record-breaking year with 158 organ donors, a 150% increase in three decades.

Throughout her distinguished career, Lori has served on a variety of committees, task forces, workgroups and advisory panels for organizations including the National Institutes of Health, the North American Transplant Coordinators Organization, National Kidney Foundation, the Organ Donation and Transplantation Alliance, the United Network for Organ Sharing and the Association of Organ Procurement Organizations (AOPO).

Lori's peers say the attributes that made her such a successful leader are her confidence, expertise, ability to build relationships, attention to detail, humility and direct communication style.

It was a privilege to present Lori with this well-deserved special recognition. And, it was inspiring and heartwarming to hear her colleagues, friends and family talk about her at the luncheon.

Aleia Manning is a graduating Medical Anthropology student at the University of Pennsylvania and an incoming Master of Health Administration student at Cornell University. With aspirations to work toward decreasing socioeconomic health disparities, she hopes to embody the spirit of this scholarship award in her continuing education and in her career.

Aleia's undergraduate education has exposed her to the history of healthcare and how that history created and maintains disparities in health outcomes across the divides of socioeconomic class and race in the United States and beyond. Her graduate studies in the administration of healthcare will help her learn the intricacies of American healthcare systems and healthcare-oriented businesses with the goal of implementing substantial change within these spheres.

Aleia's special interests revolve around maternal healthcare disparities in the U.S. relative to comparable countries, especially as they pertain to the disproportionate maternal and neonatal outcomes between Black and White populations. Over the past four years, Aleia has conducted a wealth of research and taken many classes within this area. She currently works as an administrative assistant for an annual summer program at the University of Pennsylvania with the aim to increase the representation of underrepresented populations in health services research, so that academia can become more diverse in its breadth and study designs targeting underserved populations are better oriented toward those communities' worldviews and real needs.

Aleia hopes to continue in this vein through her future work opportunities at Cornell.
